With this bus service, the Takla Nation strives to provide safe, comfortable, affordable and predictable transportation between Takla Landing and Prince George.

This brochure summarizes bus rules, schedule, ticket sales and contacts for more information and to give feedback.

Wheelchair Access

Service will be extended to all passengers, to the best of our ability, notwithstanding physical limitations. This bus is wheelchair accessible and our Ambassador is here to help. Please alert us to your needs before you travel so that we can make arrangements and allow enough time to assure safe and comfortable travel for all passengers. **Please arrive early.**

Fares and Ticket Sales

Tickets cost \$40 for a one-way ticket. Your ticket will be validated when you ride with a date stamp and a pick up/ drop off point. Tickets are sold at two locations:

Bus Rules— Passenger Conduct

For everyone's safety and comfort, passengers must follow the bus rules in the "***Passenger Conduct Policy***" summarized below and available at <https://taklafn.ca/transit/> or on the bus.

Breaking the rules will result in either temporary or permanent prohibition from riding the bus. The Driver and Ambassador are in charge of safety and comfort and have the final say.

Passengers are welcome to travel with a valid ticket according to the following rules:

1. *No taking drugs or drinking alcohol on the bus.*
2. *Drunk or abusive people can't get on the bus or will be put off the bus.*
3. *Nuisance or annoying behaviour or damage to the bus won't be tolerated.*
4. *Pick up and drop off will be at designated stops only. No exceptions.*
5. *Remain seated with seatbelt on while bus is in motion.*
5. *Keep noise levels low.*
6. *Provide the necessary information for the trip record before the bus leaves.*
7. *Board and re-board (at rest stops) at the scheduled time. Late passengers may be left behind.*
8. *Present a valid ticket before boarding/ re-boarding the bus.*

Bus Rules— Children With No Adult

To ensure safe and comfortable travel for children, passengers and parents must follow the bus rules in the "***Child Passenger & Unaccompanied Child Policy***" summarized below and available at <https://taklafn.ca/transit/> or on the bus.

Passengers 13 years or older can ride without supervision.

A child between 6-13 years can ride without supervision according to the following rules:

1. *A child younger than 6 years of age must be accompanied by someone older than 13 years of age.*
2. *No more than three children (under 13) can travel without someone over 13 years of age.*
3. *The above age limits refer to the age of the child on the date of travel.*
4. *Unaccompanied children must sit at the front of the bus.*
5. *The Parent/Adult must read, complete and sign a copy of the policy to confirm that they and their child/ children have understood the rules.*
6. *The Parent/Adult must remain with the child until boarding of the bus starts.*

Extra time and information are needed for a child to travel without an adult. **Please arrive early.**
